## REMEMBER THESE STEPS

### Take the admission test

Register at <http://www.cisiaonline.it> and sign up for the English TOLC-I, TOLC-I with English section or TOLC-S with English section, or register at <https://collegereadiness.collegeboard.org/> and take the SAT.  
Comply with the dates specified in the call for applications to take the test.

### Register for pre-selection (mandatory if you are a non-EU citizen)

Register for the pre-selection by submitting your application on the **QS MoveIn** platform by the deadlines indicated in the following link: <https://www.uniroma1.it/en/admissions>. If the pre-selection is successful, accept the programme's offer on the platform and download the pre-acceptance letter. A **30 euros payment** applies, which is distinct from the subsequent payment of 10 euros for access to the ranking list. The deadline for non-EU citizens, residing abroad and applying for a study visa is **April, 29 2025**.

### Apply for the Visa (Non- EU citizens)

If you are a non-EU citizen and reside abroad, you have to access the [Universitaly platform](#) to apply for a student visa, complete and submit the application by June 30, 2025.

### Register on Infostud

Register on Infostud at the link <https://www.uniroma1.it/en/pagina-strutturale/students>.  
Please Note: Spid or Cie credentials are required for registration (only for Italian citizenship).  
At the end you will obtain your Student ID number

### Pay the €10 fee for the selection

[Log into Infostud](#)  
Go to "Bachelor's and Master's Degree Programmes"  
Go to "Admission to programmes"  
Enter your degree programme code  
Go to Continue and then to Next  
Click on PagoPa direct payment  
Pay attention to the deadlines for carrying out the payment

### Check the rankings

Rankings are published on <https://www.uniroma1.it/en/pagina/restricted-access-degree-programmes-tolc-i-and-selections> based on the score obtained for the test, in compliance with the criteria and dates laid down in the call for applications.

### Pay the pre-enrolment or enrolment tuition fee

If you are successful in the **first selection** you must pay the pre-enrolment tuition fee.  
If you are successful in the **second or third selection** you must pay the programme enrolment tuition fees by the deadline. If you are successful but do not pay the enrolment fees by the deadlines set out in the call for applications, you will not be admitted to the programme.  
Please Note: If you are a tax resident in Italy in order to pay the reduced amount you have to calculate your [Isee 2025](#) for the right to academic education in time. You can go to a Tax Advice Centre (*Caŕ*) or visit the [Inps website](#).  
If you have tax residence abroad, you will pay a fixed amount (see [section 10](#)).

# 1. Access to the degree programme

To be admitted to the restricted access degree programme in Applied Computer Science and Artificial Intelligence you must:

- register for pre-selection on Move-In, which is mandatory if you are a non-EU citizen and apply for a student visa;
- take the TOLC-I, English TOLC-I, TOLC-S (also in the TOLC@HOME mode) (see [section 4.2](#) and [Annex 1](#)) or SAT General Test (see [section 4.3](#) and [Annex 1](#));
- register for one of the selections provided (see [section 4](#))
- pay the pre-enrolment fee if you are successful in the first selection (see [section 9](#))
- pay the programme tuition fees by the prescribed deadlines (see [section 8](#) and [section 10](#)).

## Please Note

You must use the same **e-mail address** for all platforms involved in the procedure:

- Move-IN, for the pre-selection;
- CISIA or College Board, to take the admission test
- Infostud, for payments of contributions due to the University

Please verify the accuracy of the email address provided and check your inbox periodically.

# 2. Requirements for participation in the selections

## 2.1 - For Italian citizens, citizens of another EU country and citizens of a non-EU country with a regular residence permit in Italy (EU equated)

If you have one of the citizenships below:

- Italian;
- EU country other than Italy;
- non-EU country and you hold a regular residency permit (article 26 of Law no. 189/2002)

in order to take part in the selection you must meet the requirements below:

- **High school diploma** obtained or to be obtained in the year 2025.  
If you have a qualification obtained in a foreign secondary education system, you should carefully read the list of required documents on Sapienza University's website [Go to the page](#);
- **TOLC-I, English TOLC-I or TOLC-S (also in TOLC@HOME mode)** taken from July 1, 2024  
or  
**SAT General Test taken** from January 1, 2024  
and by the deadlines provided for each selection (see [section 8](#));
- **Adequate knowledge of the English language** (see [Annex 2](#)).

## 2.2 - For non-EU citizens applying for a student visa

If you are a non-EU citizen (or have Chinese citizenship and have applied for pre-enrolment in the "Marco Polo" project for Sapienza University in the 2024/2025 academic year) you reside abroad and need to apply for an incoming study visa, **you can only take part in the first two selections** and must meet the following requirements:

- **High school diploma** obtained or to be obtained in the year 2025.  
If you have a qualification obtained in a foreign secondary education system, you should carefully read the list of required documents on Sapienza University's website [Go to the page](#);
- **TOLC-I, English TOLC-I or TOLC-S (also in TOLC@HOME mode)** taken from July 1, 2024  
or  
**SAT General Test taken** from January 1, 2024  
and by the deadlines provided for each selection (see [section 8](#));
- **pre-acceptance letter** for the degree programme in Applied Computer Science and Artificial Intelligence downloaded in .pdf format following the positive outcome of the pre-selection procedure carried out through the address <https://www.uniroma1.it/en/admissions>."

- **online pre-enrolment application** for the "University enrolment" study visa for the academic year 2025-2026 on the University website (<https://www.universitaly.it/>) filled in and sent compulsorily by June 30, 2025. Pre-enrolment on the University website is mandatory in order to obtain an entry visa for study purposes. Please note: pre-enrolment alone does not allow admission to degree programmes. To enrol, you must follow the procedures set out in this call for applications. For information:

#### Please Note

Pre-enrolment alone does not allow admission to degree programmes; in order to enrol, it is necessary to complete the procedures laid down by Sapienza University for the chosen degree programme.

### 3. MoveIN pre-selection

The MoveIN preselection (accessible from <https://www.uniroma1.it/en/admissions>) allows for a preliminary assessment prior to the subsequent selection process.

To register for the pre-selection you must follow the directions published on <https://www.uniroma1.it/en/admissions>.

The MoveIN pre-selection procedure is **compulsory** for **non-EU citizens resident abroad** (see [Annex 3](#)) and the application must be completed and submitted no later than April 29, 2025.

The assessment of the application will be made on the basis of the GPA (minimum required 75/100).

#### To take part in the pre-selection you must have:

- a high school diploma (or corresponding qualification) obtained by the school year 2024-2025, following no less than 12 years of study,
- an adequate knowledge of the English language attested according to the parameters indicated in [Annex 2](#);
- the **result of at least one of the admission tests** indicated in [section 1](#) with a score obtained no lower than 36/100, according to the concordance table in sections [A1.4](#) and [A1.5](#) of Annex 1.

The positive outcome of the pre-selection is communicated by e-mail, with a **pre-acceptance letter** containing **an offer that you will have to accept**.

The time windows within which it is possible to participate in MoveIN pre-selections are indicated in [section 8](#).

#### 3.1 MoveIN for non-EU citizens residing abroad

If you are a non-EU citizen and residing abroad, **when accepting the offer you will have to:**

- fill in and submit within **June 30, 2025, the pre-enrolment application on Universitaly** (<https://www.universitaly.it/>) to apply for a student visa;
- **take part in the selection process.**

#### Please Note

##### You cannot access the programme if:

- You do not receive the pre-acceptance letter;
- You receive the pre-acceptance letter, but you do not accept the offer;
- You receive the pre-acceptance letter, and you accept the offer but do not pass the subsequent selection.

## 4. Selections

To take part in the selections you must:

- Take one of the admission tests of your choice between: TOLC-I, English TOLC-I, TOLC-S (also in TOLC@HOME mode) from July 2024 or SAT from January 2024 and by the deadlines indicated below;
- register on Infostud (see [section 4.4](#));
- pay the 10€ fee (see [section 4.5](#)) within the deadlines indicated below;

Taking the test, registering for Sapienza University services and paying the fee must be completed by the deadlines set for each selection, under penalty of exclusion from the rankings.

Three selections are foreseen.

Any places not filled in one selection will be made available for the next selection.

\*\* by the deadline indicated the score obtained in the SAT must be submitted, see [section 4.3](#).

### Please Note

- If you take the test by the registration deadline but do not pay the €10.00 fee by the deadline, **you will not be able to participate in the selection.**
- If you pay the €10.00 fee by the deadline for registration for the selection but do not take the test by the deadline, **you will not be able to participate in the selection.**
- **If you take part in several selections**, you will have to pay the €10.00 fee each time by the deadlines indicated for each selection.

### 4.1 – Admission test

In order to participate in a selection, you have to take one of the following tests:

- **TOLC-I** (CISIA Test Online– Engineering), **English TOLC-I** or **TOLC-S** (CISIA Test Online– Science), managed by the **CISIA** consortium <https://www.cisiaonline.it/> or
- **SAT** (Scholastic Assessment Test) **General Test**, managed by the **College Board**

(<https://collegereadiness.collegeboard.org/>).

If you are a **EU citizen**, passing the SAT or English TOLC-I counts **as proof of English language proficiency**.

If you are a **citizen of a non-EU country** or have taken the TOLC-I or TOLC-S test in Italian, please refer to the information contained in [Annex 2](#).

## 4.2 – Registration for TOLC

If you choose to take the **TOLC-I** or **English TOLC-S** you need to log on to the CISIA consortium website at <https://www.cisiaonline.it/>, where you will also find the registration procedures and **test schedule**.

The following tests taken between **July 1, 2024**, and the deadlines indicated in [section 4](#) are valid:

- TOLC-I @HOME or @University;
- TOLC-S @ HOME or @University
- English TOLC-I @ HOME or @University;

You can register for tests organised by Sapienza University or any other university on the CISIA calendar.

### Please Note

- **The tax code** that you enter on the Cisia website when registering for the TOLC must correspond to the one you indicate when signing up for Infostud (see [section 4.4](#)) otherwise it will be impossible to acquire the marks obtained in the test.
- **Any TOLC tests beyond the deadline indicated in [section 4](#)**, even if organised by Sapienza University of Rome, are not valid for participation in the selections of this call for applications.

**Registration closes approximately one week before the test date**

The results of the TOLC-I, English TOLC-I and TOLC-S tests are automatically entered into Sapienza's Infostud system. Therefore, the **tax code** entered on the CISIA website when registering for the test must correspond to the one entered when signing up for Infostud, in order to allow the association of the score obtained with your student ID number.

If you take the test several times, the best score obtained will be taken into account for ranking purposes.

## 4.3 – Registration for SAT

If you choose the **SAT** (see [Annex 1](#) section A1.2) you have to log on to <https://collegereadiness.collegeboard.org/>, where you will also find the registration methods and the **test schedule**.

The SAT may be taken between **January 1, 2024**, and the deadlines indicated in [section 4](#) at any of the SAT Centres worldwide.

The test score, **SAT Score**, must be submitted via the College Board portal

<https://collegereadiness.collegeboard.org/sat/scores/sending-scores/how-to-send>.

SAT scores must be received by the University within the deadline for taking part in the selections (see [section 4](#)). We therefore recommend that you carefully check the SAT Score delivery timing on the College Board website: <https://collegereadiness.collegeboard.org/>.

If you have Italian citizenship, you need Spid or Cie credentials.

## Please Note

The e-mail address you enter when registering will be used for any communications from the University, so please check your e-mail box periodically during the steps of the procedure.

If you already have an Infostud registration you have to verify/enter your email address on the Idm dashboard, logging in with your Spid/Cie credentials or with your student ID number and password <https://idm.uniroma1.it/>

## 4.5 – Payment of the €10 fee for the selection

To pay the €10 fee:

- access Infostud at <https://www.uniroma1.it/en/pagina-strutturale/students> signing in with Spid or CIE credentials (international students sign in with their student ID number/password)
- Click on “Bachelor’s and Master’s Degree Programmes”
- go to “Admission to programmes”.
- enter the code **14824**;
- go to Continue and then Next
- Click on Direct Payment (PagoPA)

Payment of the fee is to be made by **direct payment** (online, by credit card).

The €10.00 fee is non-refundable under any circumstances.

For the academic year 2025-2026, the places available for admission to the bachelor's degree program are divided as follows:

**Note 1** - Places reserved for those who have Italian citizenship, citizenship of another EU country and citizenship of a non-EU country but hold a regular residence permit in Italy (art 26 of Law No. 189/2002 – Annex 3 [section A3.1](#)).

**Note 2** - Places reserved for those who have non-EU citizenship, permanently reside abroad and apply for student visas (Annex 3 [section A3.3](#)).

**Note 3** – Places reserved for those who have Chinese citizenship and participate in the “Marco Polo” project for Sapienza University of Rome (Annex3 [section A3.4](#)).

If the number of non-EU enrolled students (Note 2) is lower than the available places, the vacant places will be made available for those who have citizenship as specified in Note 1.

## 6. Rankings

Once the application deadlines for the selection have been completed, rankings, expressed in hundredths and structured in descending order of score, are prepared based on the criteria outlined in [Annex 1](#).

**Rankings are published** with student ID numbers at <https://www.uniroma1.it/en/pagina/restricted-access-degree-programmes-tolc-i-and-selections> and with name and surname at the Faculty Student Affairs Office.

**The date of publication of the rankings** for each selection is indicated in the calendar of procedures, in [section 8](#).

**In case of a tie**, the younger candidate in terms of age prevails.

**For candidates who have taken the admission test more than once** (as of the dates indicated in this call for applications and within the scheduled selection deadlines), **the best score obtained will be considered**.

The minimum score for admission to the programme is **36/100**.

## 7. Conditions for enrolling in the programme

### Please Note

**You must meet all the conditions and deadlines** indicated, otherwise you will not be able to enrol in the degree programme.

### If you took part in the first selection you must:

- Obtain a score higher than or equal to 36/100 on the admission test ([section 4.1](#))
- Gain a position on the ranking list within the limit of available places;
- Certify English language proficiency as described in [Annex 2](#)
- Pay the pre-enrolment fee by the specified deadlines in [section 8](#) and in compliance with the methods indicated in [section 9](#);
- Pay enrolment tuition fees by the deadlines indicated in [section 8](#) and in compliance with the methods indicated in [section 10](#).

### If you took part in the second or third selection you must:

- Obtain a score higher than or equal to 36/100 on the admission test ([section 4.1](#));
- Gain a position on the ranking list within the limit of available places;
- Certify English language proficiency as described in [Annex 2](#)
- Pay enrolment tuition fees by the deadlines indicated in [section 8](#) and in compliance with the methods indicated in [section 10](#).

If you scored less than 40/100, after enrolment and within the first year of the programme, you will have to fulfill the Further Required Courses (OFAs) in the manner specified in [section 12](#).

### Please Note

If you do not pay your pre-enrolment or enrolment tuition fees by the dates indicated in [section 8](#) **you will lose your place in the rankings**, and your place will be made available for subsequent rankings updates.

### **10.3 – Candidates who have to transfer from another Italian university**

If you are in a successful position in the ranking, you are regularly enrolled in a degree programme at

#### 10.4 – Candidates with an Italian educational qualification

If you are in a successful position in the ranking list, you already have a degree from Sapienza University or another Italian university and you wish to request a degree programme shortening or the recognition of university credits acquired during your previous degree programme, you must submit a stamped request to the Student Affairs Office (see [section 13](#)) within 15 natural and consecutive days of payment of the first instalment of the course fees.

To apply, you must follow this procedure:

If you obtained your degree at a university other than Sapienza University, you must also enclose a self-certification of your qualification complete with an indication of the exams, relative grades, Scientific-Disciplinary Sectors (SSD) and credits.

The assessment of the request will be carried out by the competent Faculty bodies.

#### 10.5 – For candidates with an educational qualification obtained from a non-Italian academic system

If you are in a successful position in the ranking list, have a degree obtained in a non-Italian academic system and wish to request a degree programme shortening or the recognition of university exams taken abroad, you must follow the instructions on the website of Sapienza University on the dedicated page [Go to the page](#)

### 11. Withdrawal from enrolment

If, after paying the first instalment of tuition fees, you wish to withdraw from the programme, you must follow this procedure:

#### Candidates with non-EU citizenship and residence permit for study purposes and withdrawal from enrolment

If you are a non-EU citizen and, holding a study visa, you have a residence permit for study purposes, withdrawing from enrolment at Sapienza University or any other university **will result in the loss of the requirements necessary for staying in Italy. Consequently, your residence permit for study purposes will be revoked.**

To enrol again, you must return to your country of origin and complete the pre-selection procedures on the QS MoveIn platform by April 29, 2025 (<https://www.uniroma1.it/en/admissions>), as well as the pre-enrolment procedures via the University online platform (<https://www.universitaly.it/>) no later than June 30, 2025.

## 12. Further Required Courses (OFAs)

Further Required Courses in **Mathematics** are given if you paid tuition fees for the degree programme as you secured a successful position in the rankings and you have obtained a score lower than 40/100 in one of the admission tests provided for by this call for applications (see [section 4.1](#)) according to the concordance table in sections A1.4 e A1.5 and [Annex 1](#).

The Further Required Courses (OFA) are fulfilled by passing **at least one of the following exams by October 31, 2026**:

- **Programming** (12 CFU)
- **Linear algebra** (6 CFU)

To facilitate the completion of the Further Required Courses (OFA), the **Faculty of Information Engineering, Computer Science, and Statistics** will provide a recorded pre-course in Linear Algebra along with dedicated tutor support.

## Annex 1. Structure of the admission test and assessment of the test

### A1.1 - TOLC-I, English TOLC-I and TOLC-S

TOLC-I and TOLC-S can be taken by those enrolled in the fourth or fifth year of high school or who have obtained a diploma. It is possible to take the test at Sapienza University or any of the CISIA member centres. In the TOLC@HOME mode, the test is taken at home. The calendar of scheduled tests can be consulted at [www.cisiaonline.it](http://www.cisiaonline.it).

Each test day is divided into several rounds; the address of the venue and the time are indicated when you register on the [www.cisiaonline.it](http://www.cisiaonline.it) portal. **You must therefore indicate the test venue when you register.**

**Please note:** registration for the test closes approximately one week before the day chosen for the test.

The TOLC registration receipt, printed from the CISIA website, must be shown on the day of the test in order to enter the test room.

**You may take each type of TOLC**, regardless of the mode of delivery, **no more than once per calendar month**, regardless of the location of the organising university you selected.

You can take the TOLC-I in both Italian and English (English TOLC-I); whereas for the TOLC-S the test is only in Italian.

The result of the TOLC is determined by the number of correct, incorrect and ungiven answers resulting in an absolute score, calculated as follows.

- 1 point for each correct answer
- 0 points for each ungiven answer
- - 0,25 points for each incorrect answer.

The minimum score is -12.5 for TOLC-I and -13.75 for TOLC-S.

The **TOLC-I in Italian** and the **TOLC-S in Italian** include an additional **English** section. The number of questions and the time available are detailed in the table below.

For the English language proficiency test, there is no penalty for incorrect answers and the score is determined by the allocation of

- 1 point for each correct answer and from
- 0 points for incorrect or ungiven answers.

This score does not count towards the score for participation in the selections. However, **it determines the partial fulfilment of the English language proficiency requirement** described in [Annex 2](#).

The score obtained in the in-person TOLC is available immediately after the end of the test, on the same terminal assigned for the test; it can be viewed and downloaded in the "test results" section of the CISIA website, by accessing your "test reserved area" with the credentials used to register on the portal.

The score obtained in the TOLC in TOLC@HOME mode, immediately viewable on the screen at the end of the test, will be recognised as official and made available, subject to verification of non-compliance of test performance as contained in the CISIA "TOLC Participants" regulations, within 48 hours of the day following the date of the test.

Those who have correctly taken the test, following the rules and behaviour indicated in the regulations, will have their TOLC@HOME result recognised/validated and will be able to access the result certificate within 48 hours from the day after the test has been taken.

**Each type of TOLC** (including the TOLC@HOME mode) may be repeated several times in order to obtain a result at least above the required threshold or to avoid the assignment of Further Required Courses (OFAs), but no more than once per month.

## A1.2 - SAT

The **SAT General Test** (hereafter, SAT) is a test used in admission procedures at colleges and universities worldwide. Delivered in English, the SAT includes a **Reading Test**, a **Writing and Language Test**, and a **Math Test**. It is administered by the College Board: further information such as the test schedule, required payments, test venues, and deadlines can be found on the College Board website:

<https://collegereadiness.collegeboard.org/>. The distribution of the number of questions and the time available

for each section are shown in the table below.

The score (**SAT Total Score**) obtained after taking the test summarises the results of the sections provided. The score is reported on a scale from **400 to 1600** and combines **the Evidence-Based Reading and Writing score** and the **Math score** (each on a 200-800 scale). The score report provides further information based on additional sub-scores. The total score is required for the admission procedure and determines the rankings.

For those who have taken the SAT **more than once** (starting from **January 2024** and within the selection deadlines), **the best score obtained from those whose submission to the College Board has been requested by the deadline indicated in [section 8](#) will be considered.**

### A1.3 - Methodological note and concordance tables between SAT, TOLC-I, English TOLC-I and TOLC-S

Considerando In order to make the results of the admission tests considered in this call for applications comparable, **a single score** expressed in **hundredths** will be used. The conversion is based on the following formulae, without allowing scores below 0 for the TOLC and scores below 600 for the SAT. Considering

- $T_{TOLC}^{\min}$  equal to 0
- $T_{TOLC}^{\max}$  equal to the maximum score obtainable with TOLC-I or TOLC-S (excluding the English section), i.e. 50,
- $T_{TOLC}$  equal to the score obtained by the candidate through TOLC-I or TOLC-S,

the unified score is calculated as follows:

$$T = \begin{cases} 0 & \text{if } T_{TOLC} \leq T_{TOLC}^{\min} \\ \frac{T_{TOLC} - T_{TOLC}^{\min}}{T_{TOLC}^{\max} - T_{TOLC}^{\min}} \times 100 & \text{otherwise.} \end{cases}$$

Considering

- $T_{SAT}^{\min}$  equal to 600
- $T_{SAT}^{\max}$  equal to the maximum score obtainable with the SAT, i.e. 1600,
- $T_{SAT}$  equal to the score obtained by the candidate through the SAT,
- the unified score is calculated as follows:

$$T = \begin{cases} 0 & \text{if } T_{SAT} \leq T_{SAT}^{\min} \\ \frac{T_{SAT} - T_{SAT}^{\min}}{T_{SAT}^{\max} - T_{SAT}^{\min}} \times 100 & \text{otherwise.} \end{cases}$$

## Annex 2 – English language proficiency requirements

In order to take part in the selection, a proficiency in English of at least level B2 according to the [Common European Framework of Reference for Languages \(CEFR\)](#) is required. To prove your command of the English language, you must meet at least one of the following requirements.

a) Provide one of the following certifications attesting the achievement of English language proficiency at level B2 also in the home edition if applicable:

- **FCE** – First Certificate in English;
- **IELTS** (academic) with a score no lower than **5.5** out of **9**;
- **TOEFL** valid and with a score no lower than **72** out of **120** (internet-based);
- **CAE** – Certificate in Advanced English;
- **CPE** – Certificate of Proficiency in English;
- **PTE** – Pearson Test of English **General, Level 3 – B2** CEFR or higher (valid);
- **PTE** – Pearson Test of English – **Academic** with a score no lower than **42**.

b) Provide proof of possession of:

- a **Diploma of International Baccalaureate (IB)**;
- or a **diploma/laurea in lingua inglese** issued by an accredited institution in the EU/EEA/Schengen or in Australia, Canada, New Zealand, the United Kingdom and the United States;
- or a **General Certificate of Education (GCE)**.

c) Provide a self-declaration attesting to **the native English speaker status**, i.e. that you have Italian or other nationality and that, due to family background or linguistic experience, you have the ability to express yourself naturally in English.

Otherwise, if you have Italian citizenship or citizenship of another EU country or you have citizenship of a non-EU country and a residency permit in Italy (Art. 26 of Law 189/2002) (see [Annex 3](#)) you can:

d) Take the **SAT** or English **TOLC-I** achieving at least a score of 36/100 according to the score concordance table in sections [A1.4](#) and [A.15](#) of Annex 1.

e) Or obtain a score of **at least 24/30** in the **English section** of the **TOLC-I** or **TOLC-S in Italian** (see [Annex 1](#)).

**Non-EU citizens applying for a student visa must upload the documents mentioned under (a), (b) and (c), to the Move-in platform.**

**Italian citizens, citizens of another EU country and citizens of a non-EU country with a regular residence permit in Italy (EU equated) must send the documents mentioned under (a), (b) and (c), to the e-mail address [acsai@di.uniroma1.it](mailto:acsai@di.uniroma1.it)**

The documents must be sent:

- either by the deadline for payment of the pre-enrolment fee (first selection);
- or by the deadline for payment of the enrolment fee (second and third selection) (see the calendar in [section 8](#)).

The subject of the email message must be in the following format: "Knowledge of English: Certificate" followed by the Student ID number obtained through Registration (see [section 4.4](#)). In the body of the message you must specify:

Your name and surname, your Student ID number, the type of English language proficiency test taken, the date on which it was taken and the score (if any). The certificate must be in PDF format in conformity with the original and must include your details and the result obtained. A certification attesting to the passing of the test alone is not sufficient.

**If you are a non-EU citizen and require an entry visa**, conditions (d) and (e) are not sufficient to prove an adequate command of the English language.

**No certificate of proficiency in Italian is required** for admission to the degree programme because all activities will be delivered in English.

## **Annex 3 –Non-Italian citizenship and/or educational qualification obtained in a non-Italian education system**

### **A3.1 – Citizenship of EU and non-EU countries holding a residence permit in Italy (EU equated)**

The general procedures of the call for applications apply to:

- EU citizens or citizens from one of the following countries: Norway, Iceland, Liechtenstein, Switzerland, Republic of San Marino, Vatican City State individuals with dual citizenship, one of which is from a European Union country;
- Non-EU citizens, holding one of the following residence permits issued by the Italian government:
  - o EU long-term resident's residence permit;
  - o Residence permit for employment or self-employment;
  - o Residence permit for family reasons;
  - o Residence permit for political asylum, subsidiary protection or special reasons;
  - o Residence permit for religious reasons;
  - o Residence card Article 50 TEU - Art 18.4 EU-UK withdrawal agreement
- Non-EU citizens who have been legally residing in Italy for at least one year and hold an upper secondary school qualification obtained in Italy allowing access to the chosen degree programme;
- Non-EU citizens who are enrolled in a degree programme at an Italian university, hold a valid residence permit for study purposes and intend to apply for a transfer or for a switch to years subsequent to their first enrolment;
- Non-EU citizens who are part (themselves or a parent or spouse) of the staff serving in foreign diplomatic missions and international organisations based in Italy, accredited to the Italian State or the Holy See. Their residence permit for diplomatic reasons must be submitted.

If you have a student residence permit in Italy issued for an Italian language course or to spend a period of exchange/mobility, follow the instructions in section A3.3.

### **A3.2 – Dual citizenship**

**If you have dual citizenship**, one of which is Italian or of another EU country, the Italian citizenship or that of another EU country prevails (Law 218 of May 31, 1995, art. 19, paragraph 2) and therefore in order to enrol on the degree programme indicated in this call for applications, you must follow the instructions provided for EU citizens and non-EU citizens regularly holding a residence permit in Italy (EU equated).

### **A3.3 – Non-EU citizenship, residence abroad and student visa application**

If you have non-EU citizenship, reside in a country other than Italy and do not meet the requirements set out in section A3.1, you must apply for an entry visa for study purposes as set out in [section 2.2](#) in order to enrol on the degree programme indicated in this call for applications.

If you have non-EU citizenship and hold a residence permit for study purposes in Italy issued for an Italian language course or to spend a period of exchange/mobility, in order to enrol in the degree programme in this call for applications you must return to your country of origin and submit an application for an entry visa for study purposes as indicated in [section 2.2](#).

### **A3.4 - “Marco Polo” Project**

If you have Chinese citizenship, are a participant of the "Marco Polo" project for Sapienza University and have submitted a pre-enrolment application to the Italian Diplomatic-Consular Representations in China, you can participate in the selection process for the places reserved for the "**Marco Polo**" project. ### A3.5 – Enrolment for candidates with a non-Italian educational qualification

To enrol within the deadlines laid down in [section 8](#) candidates with a non-Italian educational qualification must:

- Scan the documents indicated on Sapienza University's website, on the dedicated page, into a single file. [Go to the page \(3. Mandatory documents for enrolment – For all bachelor's degrees and single-cycle degrees\)](#)
- **Send** the file created to the Hello- International Student Office at the email address [studentistranieri@uniroma1.it](mailto:studentistranieri@uniroma1.it) by compulsorily stating in the subject line of the email the following: "Ready for enrolment + degree programme code and programme name + student ID number + student surname and first name".
- **Make** the payment for University tuition fees within the deadlines laid down in [section 8](#) following the specific instructions at <https://www.uniroma1.it/en/pagina/infostud-enrolment>

### A3.6 – Degree programme shortening for candidates with a non-Italian academic qualification

Those who have an academic qualification awarded by a non-Italian education system and wish to request an abbreviation of their degree programme or the recognition of university exams taken abroad must submit a request on a €16.00 tax stamp to the International Student Office within 30 days of their enrolment date.

Procedures:

- complete enrolment and pay enrolment tuition fees according to the procedures indicated in [section 10](#) activate your institutional e-mail address according to the procedures indicated on the university website on the following page <https://www.uniroma1.it/en/pagina/email-google-apps>;
- send a ticket to the International Student Office <https://tts.uniroma1.it/otrs/customer.pl> by filling in the application/request form, and uploading the documents indicated on Sapienza University's website, on the dedicated page. [Go to the page \(14. Degree programme shortening\)](#)

**Once the administrative checks have been completed, the "Hello - International Student Office" reserves the right to request additional documentation if deemed necessary and to reject the recognition request if the required conditions are not met.**

Once the necessary checks on the submitted foreign qualifications have been completed, the request will be forwarded by the Hello - International Student Office to the relevant Student Office for administrative processing.

The evaluation of the request will be carried out by the competent Faculty bodies.

## Annex 4. ISEE

The Isee (Indicator of the Equivalent Economic Situation) for the right to academic education is necessary to obtain a reduction in tuition fees (the lower the Isee value, the lower the amount to be paid).

The calculation of the Isee for the right to academic education must be requested from the Tax Advice Centres (CAF) after January 15, 2025, and at least 30 days before the deadlines provided ([section 8](#)).

For holders of a PIN code or SPID digital identity (unique code for access to all digital and online services of the Public Administration), it is also possible to request the calculation of the Isee 2025 directly online, by submitting the DSU (Dichiarazione Sostitutiva Unica) on the INPS website ([www.inps.it](http://www.inps.it)).

**For those with foreign citizenship and/or income earned abroad** who are therefore unable to provide the ISEE certification, a fixed enrolment fee is applied based on the country of origin.

## Annex 5. Disabilities and Specific Learning Difficulties

### A5.1 – Recognised disability/invalidity (Tolc and English Tolc, including in the tolca@home mode)

If you have a disability recognised in accordance with Article 3(1) or (3) of Law No. 104 of February 5, 1992, or a disability certification and you require special aids or additional time to perform TOLCs, you must declare your condition **when registering on the CISIA portal**.

In these cases, the following aids are allowed:

- additional time up to a maximum of 50% more than that defined for the TOLC;
- for taking the TOLC, depending on the certification submitted, the assistance of a tutor for writing and/or reading, a sign language interpreter, a basic calculator, accessible table (only for tests taken at university venues).

If you indicate Sapienza University of Rome as the venue at which you intend to carry out the TOLC, you must enter the necessary attestations and certifications to prove your disability status through a special document upload form provided by CISIA, which will forward the documentation to Sapienza University of Rome.

**Requests must be received by the TOLC registration deadline and must be accompanied by appropriate certification issued by INPS or by the competent structures of the National Health System (SSM).** You will be able to check the allocation of aids within the TOLC delivery platform.

### A5.2 – Specific Learning Difficulties – SPLDs (Tolc and English Tolc, including the tolca@home)

If you have a diagnosis of SLD, referred to in Law No 170/2010 and Ministerial Decree No 5669/2011, and you need special aids for the TOLC, you must declare your condition when registering on the CISIA portal.

In these cases, the following aids are allowed:

- additional time up to a maximum of 30% more than that defined for the TOLC;
- the use of the basic non-scientific calculator depending on the certification submitted.

If you indicate Sapienza University as the venue at which you intend to carry out the TOLC, you will have to enter the attestations and certifications necessary to prove your SLD status through a special document upload form provided by CISIA, which will forward the documentation to Sapienza University of Rome.

**Requests must be received by the TOLC registration deadline** and must be accompanied by appropriate SLD certification issued by National Health System (SSN) facilities or by specialists and facilities accredited by the same. You will be able to check the allocation of aid within the TOLC delivery platform.

If the attached documents do not specify the accreditation of the facilities **or specialists** who issued the certification, you must add a note with the data confirming this accreditation.

The SLD certification must be articulate and clear, with reference to nosographic codes and the explicit wording of the SLD (in reading and/or writing and/or calculation).

The diagnosis must have been issued no more than three years previously if issued for minors.

### A5.3 – Recognised disability/invalidity and SLD (SAT)

If you have a documented disability/ invalidity or a diagnosis of a specific learning difficulty (SLD) you are entitled to specific compensatory aids and modalities during the SAT test. Some of the aids available are: extra time, extra and extended breaks, and reading and vision aids. Aids must be approved by the College Board's Services for Students with Disabilities (<https://accommodations.collegeboard.org/>).

Approval can take several weeks. You should therefore start the process of submitting your request well in advance. Further information is available at <https://collegereadiness.collegeboard.org/sat/register/special-circumstances/students-with-disabilities>.

#### **A5.4 – Disability/invalidity and SLD for candidates residing abroad**

**If you have a recognised disability or a diagnosis of SLD and you reside abroad**, if you wish to take advantage of the benefits described in the previous sections, you must present the certification attesting to your disability or SLD status issued in your country of residence, accompanied by a sworn translation in Italian or English.
